Important information, please read in full, this is also considered a legal and binding contract to all that submit.

Thank you for your interest in taking part of the food truck festival. This event is sure to be well-attended! The food truck festival will be held Saturday June 8, 2019, downtown Marshall Illinois. With a wide variety of food trucks, a USAA sanctioned sprint triathlon and 5K walk/run, this event is sure to draw people from all over Central Illinois.

FEE: Application fee is \$25. The application fee is required and due at time of filling this application. Electricity & water is included. The application fee is the same if you have a truck, cart or trailer, or tent set up. No direct sale vendors will be allowed. We have the right to refuse anyone. Each participant in the triathlon will receive a \$5 voucher to use at any food truck, staff will come around at tear down to collect. A check will be mailed to you the following week.

FOR PERMITS: Each vendor is required to obtain a peddler permit by the City of Marshall Police Department, by contacting the Marshall Police Department.

PLEASE MAKE CHECKS PAYABLE TO: Marshall Area Chamber of Commerce. Once you have paid the application fee, no refunds will be given for any reason. This is a rain or shine festival. By submitting payment, you hereby agree to all terms set forth within this application.

VENDOR RESPONSIBILITIES: You will need to bring your own mobile food set up. Please submit either a photo of your mobile truck or logo (for our advertisements). Your signage and menu should be visible for patrons during the event operation hours. All areas around and under your truck are your responsibility to keep clean and free of spills or grease stains. Fines starting at \$200 will be assessed for any waste or damage left behind. Food concessions must furnish their own trash containers and all trailers must be self-contained. **Absolutely**, NO dumping of cooking grease, oil or other liquids on the ground, in storm drains or anywhere else on festival grounds.

SET UP: All Vendors must be set up and ready to open by 11:00 a.m. on Saturday, June 6, 2020. Closing/Tear down of Vendor Spaces is not allowed until 2:00 p.m. on Saturday June 6, 2020. Any vendor opening after or closing prior to the aforementioned times, will not be invited to return the following year.

IMPORTANT: NO alcoholic beverages, bottled or otherwise, maybe sold or given away at any time. If we find a vendor breaking this rule you will shut down and asked to leave the entire festival grounds and will not be refunded your application fee, no will you be approved to return.

INSURANCE: vendor is required at its sole cost and expense to carry and maintain, for the mutual benefit of itself, Marshall Area Chamber of Commerce and its officers, agents and employees, a policy of general liability insurance against claims for personal injuries, wrongful death or property damage occurring on or about the Premise with minimum amount of coverage of One Million Dollars (\$1,000,000), per occurrence, on account of bodily injury and/or death of one person and/or on account of damage to property. Such policy of insurance shall be issued by an insurance company responsibly acceptable to Marshall Area Chamber of Commerce and shall bear an enforcement to the effect that the insurer agrees to notify Marshall Area Chamber of Commerce not less than ten (10) days in advance of any modification or cancellation thereof.

Please submit the Certificate of Insurance (COI), listing the additional as insured, no later than June 1, 2019.
